Global commentary

- US markets closed lower on Tuesday, with the S&P 500 and Nasdaq pulling back from record highs amid weak corporate earnings and ahead of the Federal Reserve's policy decision. The Dow, Nasdaq, and S&P 500 dropped 0.5%, 0.4%, and 0.3%, respectively (Source: Reuters).
- European stocks ended higher, supported by regional earnings and anticipation of key policy updates from major central banks, including the Fed. The DAX, CAC 40, and FTSE 100 advanced 1.0%, 0.7%, and 0.6%, respectively (Source: RTT News).
- Asia-Pacific markets were mixed this morning following the conclusion of US-China talks in Sweden without an extension of the tariff truce (Source: CNBC).
- Oil prices jumped over 3% on Tuesday as President Trump intensified pressure on Russia over the Ukraine war and optimism rose around easing global trade tensions (Source: CNBC).
- Gold prices inched up on Tuesday as markets awaited outcomes from US-China trade discussions and the Fed's policy meeting (Source: CNBC).

Saudi commentary

- Tadawul All Share Index (TASI) dropped 0.56% to close at 10,843.91. Seventeen of the twenty-one sector indices ended in the red, led by Utilities (-3.2%) and Pharma, Biotech & Life Science (-2.4%), while Telecommunication Services (+0.6%) and Health Care Equipment & Svc (+0.3%) led the gainers. The advance-decline ratio stood at 52/199, with trading turnover at approximately SAR 4.4bn.
- The International Monetary Fund (IMF) raised its 2025 economic growth forecast for Saudi Arabia to 3.6%, up from 3% in April (Source: IMF).
- **Specialized Medical Co. (SMC)** board recommended transferring the entire statutory reserve to retained earnings (Source: Tadawul).
- Dar Al Majed Real Estate Co. (Al Majdiah) set its IPO price range on the Main Market (TASI) at SAR 13.5–14 per share (Source: Argaam).
- Nahdi posts SAR 493.6mn profit in H1 2025, up 2.6% y-o-y; Q2 at SAR 238.4mn (Source: Tadawul).
- **Leejam** posts SAR 143mn profit in H1 2025, down 14.4% y-o-y; Q2 at SAR 72mn (Source: Tadawul).
- Halwani posts SAR 13.9mn profit in H1 2025, up 29.5% y-o-y; Q2 at SAR 2.4mn (Source: Tadawul).




